SAFETY SMARTS: SAFETY SMARTS IS AN ABUSE PREVENTION TRAINING PROGRAM FOR CHILDREN IN KINDERGARTEN THROUGH FOURTH GRADE. IT IS PRIMARILY DELIVERED IN ELEMENTARY SCHOOL CLASSROOMS, BUT CAN ALSO BE TAUGHT OUTSIDE OF THE CLASSROOM OR DELIVERED VIRTUALLY, THROUGH LIVE-MEETING TOOLS SUCH AS ZOOM OR GOOGLE MEETS. THROUGH FIVE HALF-HOUR LESSONS, STUDENTS ARE GIVEN THE TOOLS TO RECOGNIZE, REFUSE, AND REPORT ATTEMPTS TO ABUSE THEM. THE STRATEGY IS TO HELP CHILDREN BECOME ACTIVE PARTICIPANTS IN THEIR OWN SAFETY AND PREEMPT COMMON GROOMING TACTICS USED BY WOULD-BE PERPETRATORS. A NEW VERSION OF SAFETY SMART IS CUSTOMIZED FOR CHILDREN WITH COGNITIVE CHALLENGES OR SPECIAL LEARNING NEEDS.
