THE CCAC ALSO PROVIDES NON-ACUTE MEDICAL EXAMS FOR THE VICTIM, ADVOCACY AND SUPPORT TO THE NON-OFFENDING CAREGIVERS, EMERGENCY FUNDS FOR FAMILIES IN NEED, AND REFERRALS TO COMMUNITY RESOURCES TO HELP SUPPORT THE RECOVERY OF THE VICTIM AND FAMILY.

INCREASINGLY, THE CCAC IS INVOLVED WHEN CHILDREN WITNESS DOMESTIC VIOLENCE OR HOMICIDE, IN CASES OF DEVELOPMENTALLY DELAYED ADULTS SUSPECTED OF BEING SEXUALLY ABUSED, AND CHILD SEX TRAFFICKING CASES. THE CCAC FORENSIC INTERVIEWERS ARE SPECIFICALLY TRAINED TO PERFORM FORENSICALLY SOUND INTERVIEWS OF VICTIMS ON THE AUTISM SPECTRUM AND THOSE WITH COGNITIVE OR COMMUNICATION CHALLENGES.
